**ORDER EXTENDING DEADLINE FOR COMMISSION ACTION TO  
FEBRUARY 24, 2025**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (“Commission”) for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

1.        On January 17, 2024, Brightspeed Companies of Kansas (Brightspeed) filed an Application for tariff revisions, including a price reduction, with the Commission, with a proposed effective date of February 1, 2025.<sup>1</sup> Brightspeed is a price cap regulated telecommunications carrier granted reduced regulation under K.S.A. 66-2005(p).

2.        K.S.A. 66-2005(p) states in part:

Following an order granting reduced regulation of an individual service or service category, the commission shall act on any request for price reductions within seven days subject to a 30-day extension.

3.        A full investigation of the Application is deemed necessary and proper. Absent an extension, Commission Staff is without sufficient time to fully review, consider, and analyze whether the proposed changes should be approved.

4. The Commission finds and concludes that extension of the deadline for consideration of the Application is required to allow sufficient time for full investigation of this matter. The deadline for consideration of the Application is hereby suspended for a period of 30 days from the date Commission action was required, from January 24, 2025, until Monday, February 24, 2025, pursuant to K.S.A. 66-2005(p).<sup>2</sup> A Commission decision may be issued before such date.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. Pursuant to K.S.A. 66-2005(p), the Application and the proposed schedule in the above-caption docket is extended, and the date for Commission action is deferred, until February 25, 2025, pending other action by the Commission

B. Any part may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>3</sup>
