STATUS UPDATE ADDING WELLS TO COMPLIANCE AGREEMENT

On July 21, 2020, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. On April 21, 2025, Staff submitted a Motion to Amend Compliance Agreement. On April 29, 2025, the Commission issued an Order Granting Motion to Amend Compliance Agreement (Amended Agreement). The Amended Agreement requires Operator to bring 85 wells into compliance with K.A.R. 82-3-111 by bringing four wells into compliance per quarter beginning September 30, 2025. The Amended Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.

The District #3 Supervisor recommends amending the Agreement to include the C Heim #1-19, API #15-103-20337; C Heim #3, API #15-103-20357; C Heim #10, API #15-103-20818; Dockendorff #1, API #15-103-20864; Laughlin #6-22D-4, API #15-011-23955; Laughlin #22-12, API #15-011-23249; Smith #6-22, API #15-011-23048; and Stewart #2-5, API #15-011-23641 wells (Subject Wells). Operator has indicated it is not opposed to the addition of the Subject Wells to the Agreement. Further, Staff recommends the final compliance deadline be extended to June 30, 2031.
