COMES NOW, Norstar Petroleum, Inc., (“Norstar”) and hereby moves to withdraw its protest without prejudice to the Application of Palomino Petroleum, Inc. (“Palomino”) for a well location exception as captioned above. In support of its withdrawal of its protest, Norstar states as follows:

1. The Motion to Intervene and Protest of Norstar was filed in this matter on January 27, 2021. The Application of Palomino seeks an Order for a well location exception.
2. Since the filing of Norstar’s Motion to Intervene and Protest, the parties have reached an agreement whereby Palomino will limit the allowable for the Spectre #1 well and Palomino filed a Motion to Amend Application and for Summary Proceedings on March 23, 2021.
3. Since the relief sought herein has been resolved, Norstar seeks to withdraw its protest without prejudice.
