Smith B #10 and Smith B #12 wells, both

located in Section 21, all in Township 29

South, Range 9 East, Elk County, Kansas.

1. In light of the Commission's January 25, 2018, Order in Docket #18-CONS-3221-CPEN,

finding that Operator is barred from claiming it is not responsibile for the following two

wells,

<u>Township 29 South, Range 9 East, Elk County, Kansas:</u> a. Smith B #10, API # 15-049-21865-00-00, located in Section 21; and b. Smith B #12, API #15-049-21954-00-00, located in Section 21,

Operator wishes to include these two wells in its request for exception to the 10-year

Temporary Abandonment limit as described in the above-captioned Application at paragraphs 6-10.

- While Operator believes its disclaimer of responsibility for these two wells was and is valid, Operator cannot afford to let this issue to stand in the way of its license reinstatement, in Docket #18-CONS-3221-CPEN.
- 3. In summary, the above-captioned Application is amended as follows:
  - a. Operator withdraws its request at paragraphs 12 and 13 of the Application, and wishes those two paragraphs to be stricken from the Application.
  - Operator wishes the above-listed two wells to be added to the list in paragraph 3 of the Application, which list is the "Wells" for which temporary abandonment is sought.

WHEREFORE, Operator requests that the Commission grant a 3-year exception to the 10-year temporary abandonment limitation for all of the Wells in paragraph 3 of the Application, as amended, without need to reapply during that 3-year period; and no protest to this Application having been received, that the Application be granted without hearing, and for such other relief as the Commission deems necessary and appropriate.


