Kansas Gas Service, a Division of ONE Gas, Inc. (“Kansas Gas Service” or “Company”) respectfully amends its annual Gas Supply Plan for the 2021 calendar year filed in accordance with the Order issued by the State Corporation Commission of the State of Kansas (“Commission”) on June 21, 2001, in Docket No. 106,850-U / 75-GIMC-009-GIG (“Order”). In support thereof, Kansas Gas Service states the following to the Commission:

**I. DESCRIPTION OF KANSAS GAS SERVICE**

1. Kansas Gas Service is a natural gas public utility operating in the State of Kansas pursuant to certificates of convenience and necessity issued by the Commission. Kansas Gas Service’s principal place of business is located at 7421 West 129th Street, Overland Park, Kansas 66213.

**II. NATURE OF FILING**

2. On August 3, 2021, Kansas Gas Service filed confidential and public versions of its 2021 annual Gas Supply Plan (the “Plan”) in the instant matter.

3. In response to February 2021’s extreme winter weather event (i.e., Winter Storm Uri), Kansas Gas Service has explored additional mechanisms to mitigate its exposure to volatile natural gas prices.


