



WTC Technologies, Inc. ("Applicant") is applying for a certificate of convenience to provide local exchange and exchange access service using Interconnected Voice over Internet Protocol ("I-VoIP") technology. Applicant proposes to grow organically to provide services in all exchanges throughout the State of Kansas, including those subject to the rural exemption pursuant to K.S.A. 66-2004. Applicant will provide service to both business and residential customers.

- B. Estimated number of company service personnel assigned to telephone service who will be located in Kansas during the time periods mentioned above.**

Applicant does not have employees, but its immediate parent company, Wamego Telecommunications Company, Inc. ("Wamego Telecommunications"), a rural incumbent local exchange carrier ("ILEC") operating in Kansas, has thirty-five (35) employees. The employees of Wamego Telecommunications will be responsible for managing Applicant's day-to-day operations in Kansas.

- C. What telecommunications equipment will be deployed in the state and where will it be deployed over the period of time mentioned above?**

Applicant will provide service using state-of-the-art fiber technologies, and a Class 5 Metaswitch, located in Wamego, Kansas. Applicant will also enter into an agreement with its parent company, Wamego Telecommunications, to route VoIP traffic on Wamego Telecommunication's switch. Applicant already provides VoIP service and routes calls to the Public Switched Telephone Network ("PSTN"). Applicant obtains interconnection with the PSTN pursuant to a commercial arrangement that provides access to the PSTN. Applicant has already submitted and obtained facilities through this process.

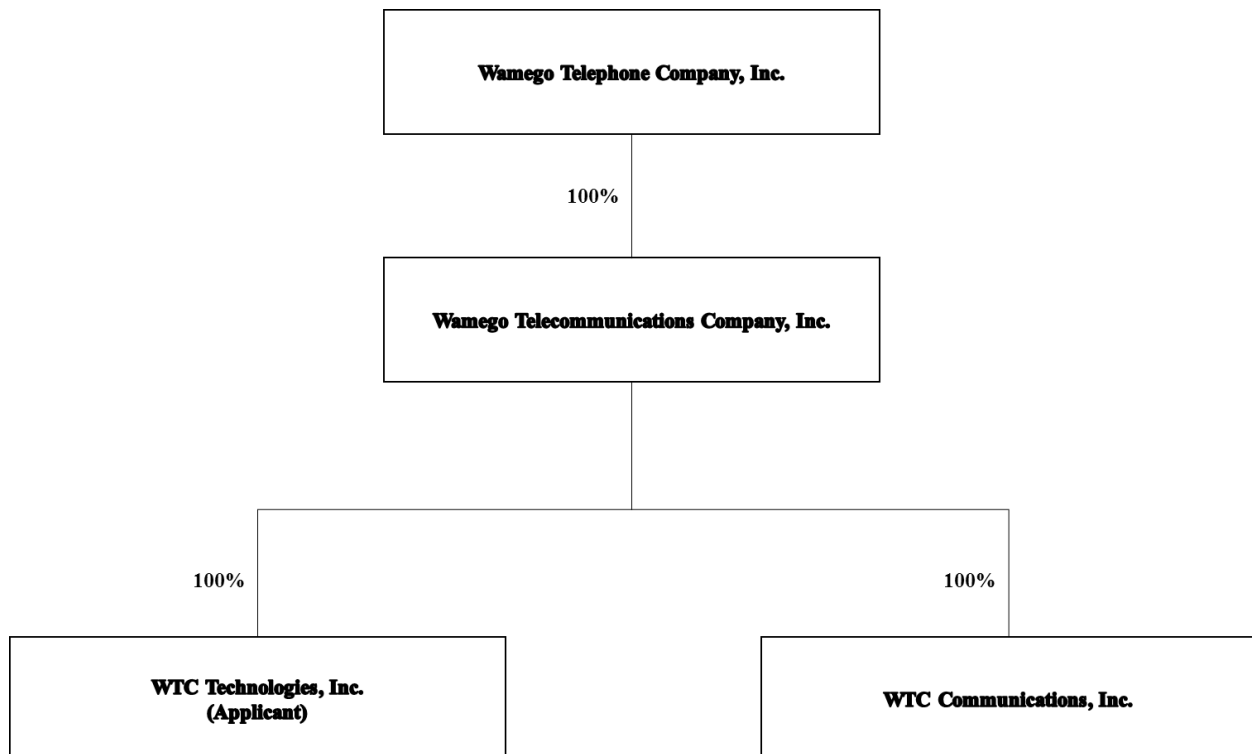

Wamego Telecommunications is in turn, a wholly-owned subsidiary of Wamego Telephone Company, Inc. (“Wamego Telephone”), a rural Kansas incumbent local exchange carrier that has been providing telephone and other advanced communications services since 1912. Since 1999, Wamego Telephone has provided local telecommunications and exchange access service to customers in Kansas through its wholly-owned subsidiary, Wamego Telecommunications (*See* KCC Docket No. 00-WTCT-155-CCN) and since 2005, competitive local exchange service through its wholly-owned subsidiary WTC Communications, Inc. (*See* KCC Docket No. 05-WCMC-1034-COC).

Applicant’s affiliate, WTC Communications, Inc., is a wholly-owned subsidiary of Wamego Telecommunications, and has been authorized to provide interexchange service in Kansas since October 1999 (*See* KCC Docket No. 00-WCMC-329-COC), and local exchange and exchange access service in Kansas since July 2005 (*See* KCC Docket No. 05-WCMC-1034-COC).
