APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND AUTHORITY TO TRANSACT THE BUSINESS OF AN ELECTRIC PUBLIC UTILITY, TRANSMISSION RIGHTS ONLY

COMES NOW Evergy Kansas Central, Inc. d/b/a Evergy Kansas Central ("Evergy Kansas Central"), and in support of its Application for a Certificate of Public Convenience and Authority, for Transmission Rights only, states:

- 1. Evergy Kansas Central is a Kansas corporation authorized by the Commission to conduct the business of a public utility under the provisions of K.S.A. 66-104, and as such holds a Certificate of Convenience and Authority from this Commission to engage in the business of an electric public utility in the State of Kansas, thereby promoting public convenience.
- 2. Evergy Kansas Central seeks, subject to the Commission's approval, transmission rights only in Butler Rural Electric Cooperative, Inc. ("Butler") certified territory defined as the 115 kV Transmission Line Project, WR P26365 described below from the northernmost to southernmost extent:

GREENWOOD COUNTY, KANSAS

Beginning in the Evergy Kansas Central's territory at the existing East Eureka Substation in the SE ¼ of Section 35, Township 25S, Range 10E; thence east through the south portion of the SE ¼ of Section 35, Township 25S, Range 10E; thence east entering the SW ¼ of Section 36, Township 25S, Range 10E; thence east through the south part of Section 36, Township 25S, Range 10E; thence south in the SE ¼ of Section 36, Township 25S, Range 10E; thence entering the NE ¼ of Section 1, Township 26S, Range 10E; thence south through the far east part of Section 1, Township 26S, Range 10E; thence entering the NE ¼ of Section 12,

Township 26S, Range 10E continuing SE ¼ of Section 12, Township 26S, Range 10E; thence SE entering the SW 1/4 of Section 7, Township 26S, Range 11E continuing SE for approximately 0.22 miles; thence south in the NW ¼ of Section 18, Township 26S, Range 11E; thence south through the west portion of Section 18, Township 26S, Range 11E; thence SW in the SW 1/4 of Section 18, Township 26S, Range 11E; thence SE 1/4 of Section 13, Township 26S, Range 10E; thence south through the east part of Section 13, Township 26S, Range 10E; thence east through Section 24, Township 26S, Range 10E; thence entering NE 1/4 of Section 25, Township 26S, Range 10E; thence west through the N ½ of Section 25, Township 26S, Range 10E; thence south in the NW 1/4 of Section 25, Township 26S, Range 10E; thence south along the far west edge of Section 25, Township 26S, Range 10E; thence south along the far west edge of Section 36, Township 26S, Range 10E; thence west in the far SW corner of the SW 1/4 of Section 36, Township 26S, Range 10E; thence west along the south edge of Section 35, Township 26S, Range 10E for 0.5 mile where it leaves the Evergy Kansas Central territory and enters the Butler County Coop territory.

The line enters the Butler County Coop territory in the far south edge of the SW ¼ of Section 35, Township 26S, Range 10E; thence continuing west for 0.45 miles of Section 35, Township 26S, Range 10E; thence SW and enters the NW ¼ of Section 2, Township 27S, Range 10E; thence south for 0.5 mile in Section 2, Township 27S, Range 10E and leaves the Butler County Coop territory and enters the Evergy Kansas Central territory.

The line enters Evergy Kansas Central territory in the SW ¼ of Section 2, Township 27S, Range 10E; thence south along the west edge of Section 2, Township 27S, Range 10E; thence along the west edge entering the NW ¼ of Section 11, Township 27S, Range 10E; thence SW in the SW ¼ of the NW ¼ of Section 11, Township 27S, Range 10E; thence entering the SE ¼ of the NE ¼ of Section 10, Township 27S, Range 10E; thence south along the east edge of Section 10, Township 27, Range 10E; thence south along the east edge of Section 15, Township 27S, Range 10E; thence east in the SE ¼ of Section 15, Township 27S, Range 10E; thence entering the SW ¼ of Section 14, Township 27S, Range 10E terminating at the Otter Creek substation located in the SW ¼ of Section 14, Township 27S, Range 10E in Greenwood County, Kansas. See Exhibit A.

- 3. Evergy Kansas Central is requesting transmission rights in the above territory for approximately 12.65 miles of new 115 kV transmission line from the new Otter Creek substation into Eureka, to make the system more reliable. The new lines will be located within a new 125-foot right-of-way.
- 4. The purposed project will upgrade an old power system that was built in the 1970s and 1980s, that had little opportunity for maintenance due to being on a large radial feed

that does not readily allow for maintenance outages. The East Eureka and Vaughn systems

account for approximately 20MW of load and are fed out of West Emporia by more than 40

miles of 115kV line, for a total of about 800 MW-miles. There is no generation available in this

area with minimal connections to other systems (34kV) for backup, making it a prime candidate

to be considered for expansion to loop the facilities.

5. A study was done by Burns & McDonnell including feedback from landowners to

determine the final route.




