**ORDER GRANTING LITTICH'S MOTION TO FILE OUT OF TIME, RESPOND TO  
KCPL'S RESPONSE, AND ADD RECORD**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed its files and records, the Commission finds:

1.        On March 8, 2017, Commission Staff (Staff) filed its Second Report and Recommendation (R&R), voicing its continued support for its recommendations from its initial R&R dated December 15, 2016,<sup>1</sup> and recommending the Commission order Kansas City Power & Light (KCP&L) to show cause as to why it should not be required to take the actions Staff outlined in the first and second R&Rs.<sup>2</sup> Staff believes there is sufficient evidence and questions raised to justify a more comprehensive review by KCP&L.<sup>3</sup>

2.        On June 11, 2018, Littich filed a Motion to File Out of Time, Respond to KCP&L's Response, and Add Record. Essentially, Littich seeks to introduce additional photos, sections of the National Electric Safety Code, and information from the Johnson County Emergency Call Center on power-related fires.

3.        Neither KCP&L nor Staff filed any opposition to Littich's Motion.

4.        K.A.R. 82-1-217(b) allows the Commission to grant extensions of time for good cause shown. The Commission believes the evidence included in Littich's Motion may be

beneficial to members of the general public who wish to make similar complaints. Therefore, the Commission believes there is good cause to grant Littich's Motion.

**THEREFORE THE COMMISSION ORDERS:**

A. Littich's Motion to File Out of Time, Respond to KCP&L's Response, and Add Record is granted.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>4</sup>

C. The Commission retains jurisdiction over the subject matter and parties to enter further orders as it deems necessary.
