EXECUTIVE SUMMARY:

On December 9, 2013, Staff filed a Report and Recommendation with the Commission. This report and recommendation includes the following observations made by Staff:

- "Not only is (Howison) unable to manage its financial affairs, but it is also unable to provide even a modicum of utility services to its customers without substantial assistance from consultants."
- "... Staff does not see Chapter 11 reorganization as a viable strategy for Howison going forward."²
- "Howison has demonstrated an inability to prudently manage the water system."³
- "... it is clear to Staff that Howison does not have the competency or financial wherewithal to operate the water system."

- "It is also abundantly clear to Staff that Howison's pattern of incompetency, disregard for its customers and disregard for regulatory authority demonstrates the current operator, Mr. Tim Howison, does not have the knowledge, skills, ability, or desire to provide sufficient and efficiency utility service." 5
- "Regardless of any cash infusion from a rate increase, Staff does not believe the current operator will be able to improve the customer service to a reasonable let alone satisfactory level."

I agree with Staff's observations and commend Staff for reaching its conclusion – that "Howison should not continue to operate or own the water system." It has consistently been my testimony that the Howison Heights water system is troubled and mismanaged, and that Staff's previous efforts to improve the Company's mismanagement have gone without resolution. I further agree with Staff's recommendation that an evidentiary hearing be scheduled to determine the future of the Howison Heights Water District.

While I agree with the observations and recommendations included in Staff's report and recommendation, it is my opinion that the Commission should allow Howison's interim rates, which were approved on April 17, 2013, to expire. Further, if the Commission accepts Staff's recommendation to hold an evidentiary hearing, the Commission should address Howison's rate application at that time and determine what, if any, rate increase is appropriate, and whether refunds to customers are necessary.

INTERIM RATES:

On March 19, 2013, Howison Heights, Inc. filed an application seeking Commission approval to increase its retail water rates by \$48,702, a 127% increase over the current rates. Howison also filed a Motion for Interim Rate Relief Subject to Refund on March 18, 2013. Howison's Motion requested that the rate increase of \$48,702 be put into effect on April 1, 2013 and remain in effect through December 31, 2013, or until the Commission makes a final determination regarding Howison's Application. On March 22, 2013, Staff supported Howison's request for interim rate relief stating "[i]t is Staffs opinion that Howison Heights, Inc. requires a rate increase in order to continue to provide sufficient and efficient water utility service to its customers."

The Commission approved Howison's request on April 17, 2013. In its order, the Commission granted "Howison's Motion for Interim Rate Relief Subject to Refund in the amount of \$48,702.

These interim rates shall go into effect on April 17, 2013 through December 31, 2013 and are subject to true-up and potential refund at such time the Commission rules on Howison's Application for a permanent rate increase."9

The interim rates approved by the Commission increased consumer's bills by 113%. Before its approval of interim rates, an average customer using 6,000 gallons of water a month paid a water bill of \$33.00. Under the approved interim rates, this same customer now pays a monthly water bill of \$70.19.

Since the April 17, 2013, interim rates were approved, several noteworthy events related to this case have occurred. Staff provides a chronological listing of twelve significant events on page 3 of its report and recommendation. The impact of these events – which include a 36-day boil water advisory – appear to have changed Staff's opinion of the necessity of Howison's need for interim rate relief. In April, Staff opined that Howison "requires a rate increase in order to continue to provide sufficient and efficient water utility service to its customers," Staff now concludes that "(r)egardless of any cash infusion from a rate increase, Staff does not believe the current operator will be able to improve the customer service to a reasonable – let alone satisfactory – level."11

I agree with Staff's most recent conclusion and find that it is inappropriate for consumers to continue paying 113% more for their water utility service than they were previously paying. I concur with Staff's assessment of the ominous financial condition of the Howison Heights water utility. Clearly, the infusion of cash granted to Howison in the April 17 order approving interim rates has had no positive impact on this utility. There is no evidence whatsoever that this rate increase was used to improve the utility's ability to provide sufficient and efficient service. I cannot attest to what Howison may have done with the increased revenue gained from the interim rates. Howison's history of comingling of personal and business funds makes it impossible to determine whether the additional revenues simply provided Mr. Tim Howison with extra cash for other expenses. There is no evidence the additional revenues provided by interim rate relief were used to improve the water distribution system.

I further agree with Staff – and have previously recommended – that Mr. Tim Howison no longer be allowed to operate the utility. Based upon the evidence in the record, Mr. Howison is either incapable or unwilling to do the things necessary to be a utility operator. The evidence supporting this conclusion has piled up over the past two years of investigations and inquiries and no evidence to the contrary has been discovered. Mr. Howison still does not pay Staterequired water taxes (even though he collects them from ratepayers). Mr. Howison still does not

file KCC-required annual reports in a timely manner. Mr. Howison **still** does not adhere to statutory requirements and orders issued by the Kansas Department of Health and Environment. Mr. Howison **still** has not made the improvements to the utility that have been recommended by Staff or ordered by the Commission. Howison's failure to comply with statutory requirements, as well as his willful disobedience of orders issued by State agencies, are unacceptable for a regulated utility.

Considering these circumstances, it is inappropriate for Howison to continue to be awarded with interim rate relief. I recommend the Commission allow Howison's interim rates to expire as currently scheduled on December 31, 2013. I further recommend the Commission address Howison's rate application at an evidentiary hearing to determine what, if any, rate increase is appropriate, as well as whether customer refunds are required.

RECOMMENDATIONS:

- The Commission should allow Howison's interim rates to expire as scheduled on December 31, 2013;
- The Commission should approve Staff's recommendation and hold an evidentiary hearing in this case;
- The Commission should hear testimony and weigh the evidence regarding Howison's proposed rate increase during an evidentiary hearing.
