### PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On January 9, 2020, the Commission issued a *Penalty Order* against Operator, finding one violation of K.A.R. 82-3-120 because unplugged wells remained on Operator's expired license.<sup>1</sup>
  - 2. On February 6, 2020, Operator requested a hearing.<sup>2</sup>
  - 3. On March 3, 2020, a prehearing conference was held.<sup>3</sup>
- 4. At the prehearing conference, Operator and Commission Staff agreed to set a status conference for March 24, 2020, to allow for discussion of the possibility of resolution of this matter absent the need for a procedural schedule.

#### THEREFORE, THE PREHEARING OFFICER ORDERS:
