**PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On January 9, 2020, the Commission issued a *Penalty Order* against Operator, finding one violation of K.A.R. 82-3-120 because unplugged wells remained on Operator's expired license.<sup>1</sup>
2. On February 6, 2020, Operator requested a hearing.<sup>2</sup>
3. On March 3, 2020, a prehearing conference was held.<sup>3</sup>
4. At the prehearing conference, Operator and Commission Staff agreed to set a status conference for March 24, 2020, to allow for discussion of the possibility of resolution of this matter absent the need for a procedural schedule.

**THEREFORE, THE PREHEARING OFFICER ORDERS:**
