ORDER GRANTING MOTION TO EXTEND STAFF'S TIME TO RESPOND

Staff also stated that counsel for the Operator has no objection to a one week extension of the deadline to August 17, 2017.
- 4. The Commission finds Staff's request for an extension reasonable and grants Staff's Motion.
