### ORDER CANCELLING PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. The Commission finds the following:

- 1. On June 2, 2022, Columbus Communications Service, LLC ("Columbus") filed an Application seeking an additional \$474,950 in annual Kansas Universal Service Fund ("KUSF") support. Columbus does not currently receive any KUSF support to provide universal service in rural areas.<sup>1</sup>
- 2. On June 14, 2022, Commission Staff ("Staff") filed an unopposed motion to establish procedural schedule.
  - 3. On June 23, 2022, the Commission granted the motion with modifications.
- 4. On October 25, 2022, the Parties filed a joint motion requesting, (1) approval of the stipulated settlement agreement, (2) waiver of procedural schedule, and (3) expedited treatment.
- 5. The Commission agrees that the in this circumstance, the procedural schedule is no longer necessary. The other aspects of the joint motion will be addressed in a separate order.
