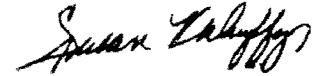

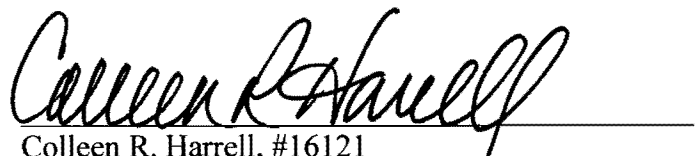

BACKGROUND:

Each year, the Commission opens a docket to determine the assessment rate for the new Kansas Universal Service Fund (KUSF) fiscal year. The fifteenth year of the KUSF (Year 15) is effective March 1, 2011 through February 29, 2012. The forms requesting the company data that Staff needs to perform all necessary KUSF calculations are attached to this memorandum. Historically, the Commission has included these attachments with its order to open the annual KUSF docket. Beginning last year, Staff recommended that all companies officially file their data in the annual docket.¹ The Commission advises all companies that they may be subject to penalties if the data is not provided in a timely manner.

Pursuant to K.S.A. 2009 Supp. 66-2005(e), on March 1, 2007 and every two years thereafter, the Commission must determine a new affordable residential and single-line business rate for rate-of-return regulated local exchange companies (LECs). K.S.A. 2009 Supp. 66-2005(e)(1) states that the affordable residential rate is the weighted arithmetic mean of the residential local service rates for the rural LECs and rate groups 1 through 3 for Southwestern Bell Telephone (SWBT) and the United Telephone Companies of Kansas d/b/a CenturyLink (CenturyLink), rounded to the nearest quarter-dollar. SWBT's rate groups 1 through 3 represent exchanges with less than

6,000 lines, while CenturyLink's rate groups 1 through 3 represent, in general, exchanges with 2,500 lines or less. Pursuant to K.S.A. 2009 Supp. 66-2005(e)(1)(C), the calculation of the March 1 affordable residential rate is based on the rates in effect as of October 1 of the preceding year. K.S.A. 2009 Supp. 66-2005(e)(2) states that the affordable single-line business rate is the existing rate or an amount \$3.00 higher than the affordable residential rate, whichever is greater.

K.S.A. 2009 Supp. 66-2005(e)(5) requires that if a company increased any local service rate after February 20, 2002 pursuant to K.S.A. 66-2007(b), the affordable rate for that company is increased by an amount equal to the rate increase.

K.S.A. 2009 Supp. 66-2005(e)(1)(C) authorizes the rural LECs to increase their rates up to a maximum of \$2.00 per year towards the affordable rates. The calculated increased local service revenues are then applied as a reduction to a company's KUSF support, consistent with K.S.A. 2009 Supp. 66-2005(d), even if the company elects to maintain rates below the affordable rates. Furthermore, in accordance with K.S.A. 2009 Supp. 66-2005(c), any intrastate access revenue adjustments are recognized in the calculation of a rural LEC's KUSF support. Therefore, any access revenue changes adopted in Docket 792 will be recognized in the calculation of the rural LECs' KUSF Year 15 support.²

On January 23, 2009, in Docket 272,³ the Commission determined an affordable residential rate of \$15.75 and a single-line business rate of \$18.75 for the rural LECs.⁴ Of the 37 rural LECs, only five companies⁵ have residential rates less than the \$15.75. These five companies do not currently receive KUSF support, but will need to increase their rates to the affordable level if they later request and qualify for KUSF support.

Prior to the amendment of K.S.A. 2009 Supp. 66-2005, the Commission addressed the affordable rate and the KUSF assessment rate in separate dockets. The Commission first opened a docket to determine the affordable rates, with the incumbent LECs providing their access lines, by rate group, as of June 30. Staff then calculated the statewide affordable rate and submitted its recommendations to the Commission. After the Commission adopted the new affordable rates, a second docket was opened to determine the next year's annual KUSF assessment rate. In this docket, the LECs provided their September 30th access line and rate data to Staff by November 15th. Staff's calculations for the new KUSF assessment rate incorporated the results from the affordable rate determination docket.

ANALYSIS:

K.S.A. 2009 Supp. 66-2005(e)(1)(C) requires that the October 1 local rates be used to calculate the statewide affordable rate for rate-of-return companies. Thus, the Commission modified the time frame in which it determines the affordable rates and the annual KUSF assessment rate, beginning with the March 1, 2007 calculations in Docket 276.⁶ The modified process includes Staff calculating the preliminary rates and submitting a memorandum of those rates to the Commission. Based on Staff's recommendations, the Commission opens one docket to address both the affordable rates and the KUSF assessment rate. The LECs rely on Staff's preliminary affordable rate calculations to submit their annual KUSF data.⁷ This approach was also used to determine the March 1, 2009 affordable rates and annual KUSF assessment rate in Docket 272.

Staff calculated the preliminary March 1, 2011 affordable residential and single-line business rates based on the tariffed residential service rates in effect as of September 1, 2010 and the access lines reported by the LECs in their annual reports for the year ended December 31, 2009. Table 1, below, shows the simple average residential rate and the percentage of residential lines for the rural LECs, CenturyLink, and SWBT and the calculated weighted-average rate for all LECs:

Table 1: Preliminary Residential Affordable Rate

Company or Group	Residential Rate	Percent of Lines
RLECs	\$15.54	44%
CenturyLink	17.73	26%
SWBT	15.70	29%
Weighted Average Rate	\$16.16	100%
Preliminary Affordable Rate	\$16.25	

As shown in Table 1, the weighted average rate of \$16.16 must be rounded to the nearest quarter-dollar, or \$16.25. Thus, the preliminary calculations indicate the affordable residential rate will increase from \$15.75 to \$16.25. Since the affordable single-line business rate must be \$3.00 higher than the residential rate, the preliminary calculations support an increase from the current affordable single-line business rate of \$18.75 up to \$19.25.

To finalize the affordable rate calculations, the LECs will need to submit their September 30, 2010, or October 1, 2010, access lines and rates, by rate group, in addition to other data necessary to perform the KUSF Year 15 calculations. In order to gather the necessary data, Staff has included the following Attachments with this Memorandum:

<u>Attachment</u>	<u>Who Should File</u>
A	Any incumbent and Competitive Eligible Telecommunication Carrier (ETC) seeking KUSF support in SWBT's study area;
B	all incumbent LECs, with SWBT and CenturyLink completing the information for rate groups 1 through 3;
C	SWBT and any competitive ETC providing service via its own facilities (excluding Local Wholesale Complete (LWC) and seeking KUSF support in SWBT's;
C-1	Sage Telecom, Inc. (Sage) and Nex-Tech, Inc.; competitive ETCs providing service via LWC in SWBT's study area and that qualify for KUSF support;
D	CenturyLink and any competitive ETC providing service and seeking KUSF support in CenturyLink's service area;
E	any competitive ETC seeking KUSF support in a rural LEC study, including in the exchanges purchased from CenturyLink, for which KUSF support is based on the cost-model.

With regard to Attachment B, any rural LEC that receives KUSF support and has an affordable residential or single-line business rate below the preliminary \$16.25 and \$19.25 rates should reflect a monthly rate increase up to the \$2.00 maximum. Companies with rates above the preliminary affordable rates are not required to complete Attachment B. Any rural LEC that is not receiving KUSF support will not file Attachment B, unless a rate increase is necessary based on a company-specific audit or access revenue changes approved in Docket 792; in which case the rate increase will be based upon the amount necessary to offset the related KUSF support. And, for those companies with a unified residential and business rate, the unified rates or affordable rates will be adjusted to allow them to recover an amount of revenue equal to what would be recovered if such a rate was not in effect. Further, pursuant to K.S.A. 2009 Supp. 66-2007, companies that implemented the \$1.50 rate increases after February 2002 will need to increase their rates \$1.50 above the affordable rates.

This approach will allow Staff to finalize the affordable rate calculations and incorporate the results in its KUSF Year 15 testimony and calculations. To the extent that the affordable rates change from the preliminary calculations, Staff will work with the companies to incorporate the appropriate adjustments.

RECOMMENDATION:

Staff recommends the Commission open one docket to address both the affordable rates for rate-of-return regulated companies and the KUSF Year 15 assessment rate. Staff recommends that the rural LECs utilize the \$16.25 and \$19.25 preliminary affordable residential and single-line business rates, respectively, to complete Attachment B. SWBT and CenturyLink should provide line count and rate information for rate groups 1 through 3 on Attachment B.

To allow companies sufficient time to implement billing changes, the Commission generally issues an order adopting the new KUSF assessment rate around January 23. Thus, to allow Staff time to review the voluminous amount of data and perform the necessary calculations, Staff recommends that companies file their data in the docket by November 3, 2010. Staff also recommends that companies be reminded to file not only the applicable Attachments, but also supporting line data documentation. Staff also recommends that the Commission remind companies that they may be subject to penalties if the required information is not provided by the due date. Lastly, Staff recommends that the Commission adopt the following procedural schedule:

Attachment A

A. Lines Eligible for KUSF Support

<u>Category:</u>	<u>Comments</u>
Total Residential Lines (Landline & Wireless)	Retail residential lines in a "high-cost" area, as determined by the Commission, and billed a EUCL. A Rural LEC study area receiving KUSF support is considered to be a high-cost area. For SWBT and CenturyLink study areas, a high-cost area is a wire center zone that qualifies for KUSF support, as determined by the high-cost model adopted in Docket No. 99-GIMT-326-GIT. Include residential concession lines consistent with the "Concession Line" definition. Wireless Lines are reported based on billing address.
Total Business Lines (Landline & Wireless)	Include all retail single and multi-line business lines in a "high-cost" area. Include all lines terminating in a hunt group, including Key lines, PBX, and Centrex. Include business concession lines consistent with "concession line" definition. Include company-official, Payphone stations, and other lines. (5/24/02 Report on Line Synchronization, Docket No. 99-GIMT-326-GIT). Wireless lines are eligible for support based on billing address.
Concession Lines	If a Concession Line is charged the full monthly service rate, the line is reported and eligible for KUSF support. A concession line that does not pay any monthly service rate (i.e provided free of charge) is not eligible for KUSF support. A concession line provided at a reduced rate is reported on an "Equivalent Full Line" basis. Report the "Equivalent Full Line" count in the Total Residential or Total Business Lines. Example: a residential concession line charged 100% of the monthly service rate is reported as 1 residential line. If 10 residential lines are charged 50% of the monthly service rate, each line is counted as 50%, with the 10 lines at 50% service rate equal to 5 lines reported in the residential line count. (Docket 01-GIMT-235-GIT).

B. Lines Not Eligible for KUSF Support

Non-Kansas jurisdictional lines	Lines in other states, or that are not subject to the KCC's jurisdiction.
Hunt Lines, including Key, PBX, and Centrex and all Wireless Business Lines when 4 or more lines have same billing address.	All lines that terminate in a Key, Centrex, PBX, or othe Hunt-group setting. (Docket No. 99-GIMT-326-GIT, 5-24-02 Report on Synchronizing Line Counts, and Docket 02-GIMT-068-GIT). For Wireless: If 4 or more business phones have the same billing address, all lines for that business are considered "hunt" lines and ineligible for KUSF support.
Primary Rate Interface (PRI) Arrangements	Consists of 24 channels (23 B channels plus one D channel for signaling) & generally used by large businesses in a PBX-type setting. Similar to PBX, Centrex, Hunt Group Settings. (Docket 09-GIMT-272-GIT)
Company-Official Lines	Company-official Lines do not produce end-user revenues. (Docket No. 01-GIMT-236-GIT).

B. Lines Not Eligible for KUSF Support, Cont.

Concession Lines	Concession lines that do not pay a monthly service rate are not eligible for KUSF support. Lines that pay a portion of the monthly service rate are eligible for KUSF support on the same equivalent basis. See "Concession Line" definition. All toll or long distance revenues associated with a concession line are reported as toll or long distance revenues and subject to the annual KUSF assessment percent.
One-Way Lines (Internet, Fire, Alarm, etc.)	Lines do not provide two-way voice-grade service. (Docket No. 01-GIMT-236-GIT).
Non-Company Owned Payphone Lines	Lines not owned by the company are not eligible for support. (Docket No. 01-GIMT-236-GIT).
Resale Lines	Lines purchased from another company and resold to an end-user do not qualify for KUSF support. Does not include lines purchased under Local Wholesale Complete arrangements.

Residential Lines	Retail Residential lines billed a EUCL.
Concession Lines	Concession Lines that do not pay a local monthly service charge cannot be charged the company's per line KUSF assessment and should be excluded from this reporting. Any intrastate toll or long distance revenues may be assessed at the approved KUSF assessment percentage rate. Include only Concession lines that pay either the full, or a reduced, monthly service rate, on an Equivalent Full Line basis. For example, if 20 concession lines are charged 50% of the monthly service charge, 10 lines would be included as assessable lines since the lines may be charged up to 50% of the company's KUSF maximum per line assessment. (Docket No. 01-GIMT-235-GIT)
Business Lines	All Retail single-line and multi-line business lines billed a EUCL. All Key Lines and Lines terminating in a Centrex, PBX, or Hunt Group are assessable lines.
