## **Reply to Motion to Dismiss and Motion to Accept Protests**

COME NOW, Polly Shteamer, Protestant, who respectfully moves that the due date for the protestants pre-filed testimony due March 11, 2019, be extended two weeks to March 25, 2019. In support of her motion, Polly Shteamer states:
