PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On October 22, 2018, Abercrombie Energy, LLC (Operator) filed an Application to authorize injection of saltwater into the Mississippi formation at the Brown #1-26 well, located in Seward County, Kansas.¹ A hearing on the Application is currently scheduled for May 16, 2019, and the first pre-filed direct testimony deadline is March 25, 2019.²

2. The Prehearing Officer finds it appropriate to set a status conference in this docket, so that he may be apprised of the possibility of settlement, for potentially obtaining consent to electronic service of documents and orders; and to hear any other preliminary issues that may arise.
