MOTION TO REINSTATE INTRASTATE MOTOR CARRIER OPERATIONS

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), by and through its counsel, files its motion requesting the Commission reinstate the Kansas motor carrier operations of Kings Home Delivery LLC of Wichita, Kansas (Carrier). In support of its Motion, Staff states as follows:

- 1. Carrier is a motor carrier as defined in 49 C.F.R. Part 390.5, as adopted by K.A.R. 82-4-3f, that operates commercial motor vehicle(s) in interstate commerce.
- Carrier is registered as a motor carrier with the U.S. Department of Transportation
 (USDOT) and operates under USDOT Number 3000627.
- 3. On April 14, 2022, the Commission issued an Order suspending Carrier's intrastate motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 66-1,129, due to non-compliance with a Penalty Order issued in this docket on February 1, 2022. The Penalty Order assessed Carrier a \$1,300 civil fine.
- 4. During a recent review of records, Staff determined Carrier paid the \$1,300 penalty assessment.

- 5. Therefore, Staff asks the Commission to find that Carrier has now complied with the requirements of the above-referenced Penalty Order.
- 6. Staff also asks the Commission to reinstate Carrier's Kansas motor carrier operations.

WHEREFORE, for the reasons stated above, Staff respectfully requests that the Commission issue an order reinstating Carrier's Kansas motor carrier operations.
