**ORDER ADOPTING STAFF'S REPORT AND RECOMMENDATION
AND CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined the files, the Commission finds and concludes as follows:

1. Pursuant to K.S.A. 66-1402, "[n]o management, construction, engineering or similar contract, hereinafter made, with any affiliated interest, as defined in K.S.A. 66-1401 and amendments thereto, shall be effective unless it shall first have been filed with the commission." The Commission has the authority to disapprove such contracts found not to be in the public interest; however, no action is required by the Commission to otherwise approve of the contract.¹
2. On December 21, 2023, Kansas Gas Service, a Division of ONE Gas, Inc., (KGS and ONE Gas, respectively) filed its renegotiated insurance contract with its wholly-owned captive insurance company, Utility Insurance Company (UIC).

3. On October 10, 2024, Commission Staff filed its Report and Recommendation (R&R), advising, pursuant to K.S.A. 66-1402, that the Commission not take action to disapprove the new 2023 contract between ONE Gas and UIC.

4. On October 22, 2024, the Citizens' Utility Ratepayer Board (CURB) filed its response to Staff's R&R. Curb supported Staff's R&R and agreed that the Commission need not take action to disapprove the new 2023 contract between ONE Gas and UIC.

5. Upon review of Staff's and CURB's filings, the Commission adopts Staff's Report and Recommendation. The Commission finds it is appropriate to take no action and close this docket.

THE COMMISSION THEREFORE ORDERS THAT:

A. Staff's Report and Recommendation, filed October 10, 2024, is adopted and the Commission takes no further action and this docket shall be closed.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).²
