NOTICE OF APPLICATION AND HEARING

TO: All Oil and Gas Producers, Purchasers, Royalty Owners, Landowners, and all other persons whomsoever concerned.

YOU, and each of you, are hereby notified that Cholla Production, LLC, has filed with the State Corporation Commission of the State of Kansas an Application pursuant to K.A.R. 82-3-103a, for authority to drill its Kohl #1-33H horizontal well to test the Pawnee formation as it underlies the following described lands in Trego County, Kansas:

West half of Section 33, in T11S-R22W, Trego County, Kansas, containing 320 acres, more or less which well will be drilled at a surface location in the SE/4 SW/4, at approximately 75 feet from the South line and 2260 feet from the West line, of Section 33 and a bottom hole location located in the NE/4 NW/4, at approximately 2260 feet from the West line and 330 from the North line, of Section 33. Said well will not be located less than 330 feet from any unit boundary at its point of entry into the Pawnee formation, along its lateral or horizontal section, or at its final bottom hole location.

The application is pending before the Commission and will be granted within fifteen (15) days from publication of this notice without hearing unless a written protest is received by the Conservation Division within said fifteen-day period. Any protests to the Application must be written and should clearly state the grounds of objection. The written protest should be mailed to the State Corporation Commission, Conservation Division, Finney State Office Building, 130 S. Market, Room 2078, Wichita, Kansas 67202.

If a written protest is filed with the Commission within fifteen (15) days from the date of publication of this notice, this matter will be set for hearing on January 17, 2014, at 10:00 a.m., or as soon thereafter as it may be reached at the Commission Hearing Room, Kansas Corporation Commission, 130 S. Market, Room 2078, Wichita, Kansas 67202-3802. The time, date and location of this hearing may be revised without further notice.

All persons interested or otherwise concerned shall take notice of the foregoing and govern themselves accordingly.
