**PREHEARING OFFICER ORDER SETTING PREHEARING CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1.        On April 23, 2019, the Commission issued a *Penalty Order* against Tauy Oil, Inc. (Operator) for fourteen violations of K.A.R. 82-3-409 for failure to file annual fluid injection reports.<sup>1</sup>
2.        On May 6, 2019, Operator filed a request for hearing.<sup>2</sup> On May 21, 2019, the Commission issued an order setting a June 3, 2019, prehearing conference.<sup>3</sup>
3.        Subsequent to the June 3, 2019, prehearing conference, the parties agreed by email to set a new prehearing conference.
