- 1. On September 9, 2019, Westar Energy, Inc. and Kansas Gas & Electric Company filed a letter Application requesting authority to change their names as set forth in their tariffs and the records of the Commission to Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. d/b/a collectively as "Evergy Kansas Central."
- 2. On October 8, 2019, the Commission issued an Order Approving Name Change a provisionally approved the Adoption Tariff filed by Westar Energy, Inc.
- 3. The tariff filing omitted the word "Evergy" in the last sentence of the Adoption Tariff before words "Kansas Central, Inc."
- 4. On October 22, 2019, Evergy Kansas Central, Inc. provided a corrected tariff form. This Notice confirms the clerical correction and records the Staff's acceptance of the Adoption Tariff, as corrected, consistent with the Order of October 8, 2019. No Commission action is required. The Adoption Tariff, as corrected, is attached to the Notice.
