ORDER ADOPTING AUDIT REPORT AND CLOSING THE DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On August 6, 2024, the Commission directed Vantage Point Solutions (VPS) to perform an audit of Daywalker Mobile, Inc., (Daywalker) for Kansas Universal Service Fund (KUSF) purposes.
- 2. On September 19, 2024, VPS filed its Audit Report, indicating Daywalker had no audit deficiencies for Operating Year 27 from March 2023 to February 2024. The Audit Report stated Daywalker is current with its KUSF obligations.
- 3. VPS conducted the audit of Daywalker in accordance with the Commission's KUSF Review Procedures. Daywalker is a wireless data carrier and is headquartered in Bartlesville, Oklahoma. Based on its review, VPS found Daywalker does not have any Kansas customers at this time, therefore it is not required to report revenue and pay assessments to the KUSF until such time as revenue is generated. In accordance with its determination that no reporting deficiencies were found, VPS recommended closing the docket.

4. The Commission has reviewed VPS's Audit Report, filed September 19, 2024, and concludes it should be adopted with the docket being closed.

IT IS THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Commission accepts and adopts Vantage Point Solutions' Audit Report filed September 19, 2024.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).¹

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
