**STAFF'S MOTION FOR SCHEDULING CONFERENCE AND/OR PROCEDURAL

The Staff of the Kansas Corporation Commission (Staff) hereby moves the Commission to set a scheduling conference in this matter and/or set a procedural schedule to govern the remainder of the proceedings. In support of its motion, Staff states the following:

1. On November 15, 2014, Atmos Energy (Atmos) filed an Application in this docket asking to amend its Purchase Gas Adjustment (PGA) Schedule to add a Demand Charge Savings and Pipeline Bypass Savings Component to the PGA. Staff met with Atmos and discussed amending the Application.

2. On April 24, 2014, and based upon discussions with Staff, Atmos filed an Amended Application. In its Amended Application, Atmos agreed to waive its K.S.A. 66-117 two hundred and forty (240) day operation of law date until October 14, 2014.




