RESPONSE TO STAFF'S REPORT AND RECOMMENDATION

Kansas Gas Service, a Division of ONE Gas, Inc. ("Kansas Gas Service"), files the following response to the Report and Recommendation filed by the Staff of the Kansas Corporation Commission ("Staff" and "Commission") in the above-captioned docket on June 24, 2025 ("R&R").

Kansas Gas Service concurs with Staff's recommendation that the Commission approve Kansas Gas Service's Gas System Reliability Surcharge ("GSRS") revenue requirement of \$7,213,949 to be collected via the monthly charges listed in Exhibit 5 attached to the R&R with the following conditions:

- KGS must file a GSRS True-Up twelve months after the collection of rates from this filing; and
- Staff will review KGS's True-Up filing to ensure that the amounts recovered via the surcharge are appropriate and any over/under-recoveries will be refunded to or recovered from customers at that time.


WHEREFORE, Kansas Gas Service requests the Commission issue an order approving the GSRS revenue requirement as set forth in the R&R.


