The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On October 19, 2018, United Telephone Companies of Kansas d/b/a CenturyLink filed a request to make tariff revisions to introduce a two-year bundle option for CenturyLink Business Bundle.
- 2. K.S.A. 66-2005 (q) (1) (A) provides for statewide deregulation of packages and bundles of services.
- 3. The Commission Staff reviewed the tariff filing, which was made on 7-day notice and accepted the tariff filing as deregulated. Accordingly, the docket should be closed.

#### IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. United Telephone Companies of Kansas d/b/a CenturyLink's request for a two-year bundle option was approved according to law and the Docket is hereby closed.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529 (a) (1).<sup>1</sup>
