COMES NOW AMERICAN STAR ENERGY SERVICES, LLC (hereinafter  
“Operator”) by and through its attorney, Lee Thompson, Thompson Law Firm, L.L.C.,  
and for its written request for hearing in the captioned matter in accordance with the  
Kansas Administrative Procedure Act and states as follows:

1. Applicant is a foreign limited liability company organized to do business in the State of Kansas (Business Entity ID 2011378) and has heretofore been issued a license to conduct oil and gas activities by the Kansas Corporation Commission (“Commission”) under Operator License Number 35913. The Registered Office of Operator in Kansas is Registered Agents, Inc. 4601 E. Douglas Avenue, Suite 150, Wichita, Kansas 67218 and its headquarters place of business is 11711 S Fulton Ave, Tulsa, OK 74137.
2. The Commission has entered a Penalty Order alleging that Operator has failed to comply with a Commission order and K.A.R. 82-3-407(a) perform a successful and current Mechanical Integrity Test.

3. A hearing is requested pursuant to K.S.A. 55-164, K.S.A. 77-537, and K.S.A. 77-542, to : (a) address the issue of whether or not the issuance of the Penalty Order was accomplished properly in accord with the Kansas Administrative Procedures Act, (b) whether the Findings of Fact recited in the subject Penalty Order are supported by legally sufficient evidence, and (c) whether the subject Penalty Order is violative of due process of law and appropriately entered under applicable law and facts.

**NOW THEREFORE**, Operator prays for and requests a hearing on the above captioned order pursuant to law as set forth in paragraph 3 above.

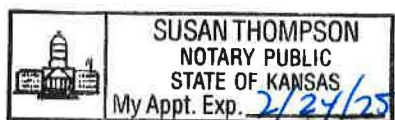
