PETITION TO INTERVENE

COMES NOW, Southeast Kansas Education Service Center – Interlocal #609 (hereinafter "Local 609") and respectfully moves the Corporation Commission of the State of Kansas (the "Commission") for an order permitting its intervention and full participation in the captioned proceeding. In support of its Petition, Local 609 states:

 Local 609 is comprised of 47 Public School Districts in the State of Kansas (Exhibit A), serving approximately 139,048 students.

2. On February 15, 2019, Westar Energy, Inc. and Kansas Gas and Electric Company (hereinafter "Westar") filed a report with the Commission to make certain changes in their Transmission Delivery Charge (hereafter "TDC").

3. The vast majority of Local 609's members takes all of their electric service from Westar, and the remaining members may well be impacted by the TDC charges proposed in this Docket.

4. Local 609's members operate 1,538 number of buildings and approximately 1,560 number of electric meters.

5. Although it appears from Westar's filing that the total TDC, for which Westar requests approval of in this docket will decrease moderately the shift between rate classes is particularly dramatic.

6. Although the calculation of the TDC and its allocation to various rate classes is extremely complicated and, apparently, now involves the use of a 12 coincidental peak formula versus a 4-coincidental peak formula used in the past, the resulting increase in Westar's proposal TDC for public schools and universities of approximately is an 85% increase over the current charge.

7. An increase of 85% to public schools constitutes "rate shock" and flies in the face of the Commission's traditional approach to gradualism with respect to introduction of new significantly increased rates for electric service.

8. Public schools are classified as their own rate class. The members of Local 609 are part of the public school rate class. Only USD 259, which takes electric service from Westar under the public school rate class has sought to intervene in this case to date. Local 609's members are public schools in small and rural communities, and the impact of the proposed TDC changes on the small rural schools may well differ than the impact on USD 259.

9. It is the duty of the public schools to prepare future workforce of Kansas through quality education services. Students of today are critical to the future economic vitality of the State of Kansas. Any electric rate changes of the nature proposed in the current docket will have a significant impact on the funding for public schools and thus impact the quality of educational services. Local 609 requests permission to intervene in this Docket and participate fully.

10. Local 609 requests the right to conduct discovery, present witnesses, cross-examine witnesses, and participate in all aspects of this Docket. The interests of justice will

be served and the orderly and prompt conduct of these proceedings will not be impaired by allowing the intervention of Local 609 to fully participate therein.
