SUSPENSION ORDER

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission makes the following findings:

1. On December 31, 2015, Kansas City Power and Light Company (KCP&L) filed an Application with the Commission seeking approval of a Residential All-Electric Rider Tariff.

2. The Commission has determined that an additional 240 days is needed to fully review the Application and suspension is required to allow sufficient time for review and investigation of this matter.

3. The Commission finds and concludes that suspension of the application and deferral of its effective date are required to allow sufficient time for full investigation of this matter. The application should be suspended for a period of 240 days from the date the application was made, December 31, 2015, until August 27, 2016, pursuant to K.S.A. 66-117(c). However, given the end of the 240-day suspension period falls on a weekend, the deadline for Commission Order in this matter is Monday, August 29, 2016, pursuant to K.S.A. 66-117(c) and K.S.A. 2015 Supp. 77-503(c).

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Pursuant to K.S.A. 66-117(c), the application in the above-captioned docket shall be suspended and the effective date deferred until August 29, 2016.

B. The parties have 15 days, plus three (3) days if service is by mail, from the date the order was served in which to petition the Commission for reconsideration of any issues decided herein. K.S.A. 66-118b; K.S.A. 2015 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
