### **CERTIFICATE**

NOW, the above-captioned matter comes on for consideration and determination by the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On January 20, 2015, Kansas City Power & Light Company ("Applicant") filed an application seeking a Certificate of Public Convenience and Authority to provide electric service to a portion of Johnson County, Kansas as required by K.S.A. 2014 Supp. 66-131. Applicant is an electric public utility as defined by K.S.A. 2013 Supp. 66-104. A public hearing was neither requested nor held on this application.
- 2. Specifically, Applicant requests a Certificate in the territory described as follows: JOHNSON\_COUNTY

A tract of land described as Lots 200-212, 216, 217 and 238-256 of Woodland Ridge, a Subdivision (Preliminary Plat) located in Northwest ¼ of Section 13, Township 15 South, Range 23 East, in the City of Spring Hill, as detailed on the map marked Exhibit B in the application.

3. The territory described in Finding No. 2 above is currently served by Westar Energy, Inc. Pursuant to Docket No. 15-WSEE-305-CCS, Westar Energy, Inc. requests

permission to cease operating as an electric public utility in that territory.

4. Public convenience will be promoted by allowing Applicant to provide electric service in the territory described in Finding No. 2 above. The application, therefore, should be granted and a Certificate issued to Applicant in accordance with the provisions of K.S.A. 2014

Supp. 66-131.

IT IS, THEREFORE, BY THE COMMISSION CONSIDERED AND CERTIFIED:

The application filed herein is granted and Kansas City Power & Light Company is permitted to transact the business of an electric public utility in the territory described in Finding

No. 2 herein.

A party may file a petition for reconsideration of this Order within fifteen (15) days from the date of service of this Order. If service is by mail, service is complete upon mailing, and three (3) days shall be added to the above time frame. K.S.A. 66-118b; K.S.A. 2014 Supp. 77-529.

The Commission retains jurisdiction of the subject matter and parties for the purpose of entering such further order or orders as it may deem necessary.

#### **EXECUTIVE SUMMARY:**

In order to properly certificate electric customers, which each utility is serving in the other's territory, Kansas City Power & Light Company (KCP&L) and Westar Energy, Inc. (Westar) have filed these Applications to exchange two small separate tracts of electric territory located in Wyandotte and Johnson Counties. Because there are existing customers located in the areas being exchanged, notice of these Applications has been provided by each Company to the affected customers, advising of the Company's intent to properly certificate the area where their customers are located. Staff has received no objection or comment from the noticed customers. Staff is recommending that the Applications be granted.

#### **BACKGROUND:**

On January 20, 2015, Westar filed 15-WSEE-305-CCS, 15-WSEE-306-COC, and 15-WSEE-307-COC and KCP&L filed companion filings in 15-KCPE-308-COC, 15-KCPE-309-CCS, and 15-KCPE-310-CCS. These Applications would provide for the exchange of two small separate areas of electric territory located in Wyandotte and Johnson Counties.

#### **ANALYSIS:**

Pursuant to K.S.A. 2014 Supp. 66-131, the Commission has jurisdiction to grant a certificate to a public utility seeking to transact business in the State of Kansas. K.S.A. 66-1,170 et seq. the Retail Electric Suppliers Act (RESA) requires each and every retail electric supplier to obtain a certificate from the Commission.

The statutory standard of review in this matter is whether the "public convenience will be promoted by the transaction of said business and permitting said applicants to transact the business of a common carrier or public utility in this state." K.S.A. 2014 Supp. 66-131. Further, single electric certification shall be the standard in Kansas under K.S.A. 66-1,170 et seq.

In addition, 66-1,175 states:

Notwithstanding the exclusive right of retail electric suppliers to provide service within the certified territories established pursuant to this act, a retail electric supplier may enter into an agreement with another retail electric supplier for the establishment of boundaries between territories other than the boundaries established pursuant to this act or providing electric service to electric consuming facilities as between such retail electric suppliers. Any agreement entered into pursuant to this section shall be subject to approval by the corporation commission. If so approved, the commission shall issue certificates accordingly.

After discovering accounts each electric utility had inadvertently connected in one another's service area, KCP&L and Westar filed these Applications to correct the territory boundary and properly certificate the customers involved. In Wyandotte County, Westar is serving five customers which are in an area certificated to KCP&L. However, all but one of these customers has been served by Westar since 1946 and are considered to be grandfathered accounts. A 40 acre tract of electric territory is being exchanged with KCP&L to properly certificate Westar at this location.

The other area being exchanged by Westar and KCP&L is located in Johnson County and occurs where an existing territory boundary between Westar and KCP&L extends through a portion of the Woodland Ridge Subdivision. At this location, KCP&L is currently serving seven customers across the boundary in Westar's portion of this subdivision. KCP&L was already serving the eastern portion of the subdivision but mistakenly connected the seven customers west of the boundary. In order to provide KCP&L proper certificate authority and divide or square up the boundary in the subdivision so that it can be more efficiently provided future electric service, from existing electric facilities, a number of undeveloped lots are being exchanged. The Applications provide that Westar would release and KCP&L would become certificated in 34 lots and KCP&L would release and Westar would become certificated in 20 lots. Often times when a boundary dissects a subdivision as it has the Woodland Ridge Subdivision, this type of territory trade is done. However, in this case the matter is more complicated due to the existing customers involved. Therefore, Staff has discussed the need for notice to these affected customers and both utilities have cooperated and after agreement between Staff and the two utilities on a notice letter format, KCP&L has mailed a notice letter to each of their seven affected customers noticing them of these Applications. In addition, Westar is providing notice to their appropriate customers.

Staff has received no objection or comments from the noticed customers.

Staff recommends that the Commission find that public convenience will be promoted by the granting of these Applications.

The Commission action date is August 19, 2015.

#### **RECOMMENDATION:**

Staff recommends that the above-captioned Applications of Westar and KCP&L be granted.
