#### MOTION TO RESCIND ORDER

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively), moves the Commission rescind the Penalty Order in this docket. In support of its motion, Staff states as follows:

- 1. On April 23, 2019, the Commission issued a Penalty Order finding the Operator had committed one violation of K.A.R. 82-3-409 because the Operator failed to file the annual fluid injection report for the subject well, reporting activity during the 2018 calendar year.
- 2. On May 28, 2019, the Operator filed a request for hearing stating that the subject well should not be listed on his well inventory.
- 3. On June 6, 2019, the Commission issued an Order Designating Prehearing Officer and Setting Prehearing Conference.
- 4. Following the receipt and review of additional information regarding this matter, Staff agrees with the Operator. The subject well was placed on his well inventory in error. Staff does not believe expending resources to prosecute this matter is in the best interests of the state.

WHEREFORE, for the reasons set forth above, Staff recommends the Commission rescind its Penalty Order and close the docket.
