**ORDER RESCINDING PENALTY**

Upon its own motion, the Commission finds and concludes as follows:

**I. FINDINGS OF FACT**

1. On November 6, 2014, the Commission issued a Penalty Order in this docket, requiring Operator to pay \$1,000 for failure to timely submit complete, accurate well completion reports and associated documents ("ACO-1's") for the Kirk Jones #3 and Kirk Jones #4-14.
2. Staff reports that Operator did not timely file ACO-1's for the wells, and that the deadline in the Notice of Violation letter had passed by the time completed ACO-1's were received by Staff. However, when Staff received the completed ACO-1's, only hours had passed since the deadline in the Notice of Violation letter. If Staff had recognized this, then Staff would not have recommended a penalty in this docket.
3. Based upon the above, Staff recommends that the Penalty Order in this docket should be rescinded.

**II. CONCLUSIONS OF LAW**

4. Based upon the above, the Commission concludes that the November 6, 2014, Penalty Order in this docket should be rescinded.


**THEREFORE, THE COMMISSION ORDERS:**


