COMES NOW Southwestern Bell Telephone Company d/b/a AT&T Kansas ("AT&T Kansas"), pursuant to K.A.R. 82-1-218 and K.A.R. 2015 Supp. 82-1-219, and hereby respectfully withdraws that portion of its July 19, 2017, Motion for Stay of Proceeding requesting a stay of the filing of briefs/responses addressing the five (5) questions identified in the Commission's July 11, 2017 Order. In support of its partial withdrawal, AT&T Kansas shows the Commission as follows:

- 1. On July 19, 2017, AT&T Kansas filed its Motion for Stay of Proceeding in the above captioned matter, including staying the filing of briefs/responses on five (5) questions identified in the Commission's July 11, 2017 Order in this proceeding.
- 2. On July 19, 2017, the Staff of the Kansas Corporation Commission (Staff) filed its Partial Opposition to AT&T Kansas' Motion for Stay. Staff objected to that portion of the AT&T Kansas Motion for Stay of Proceeding staying the filing of briefs/responses on the five (5) questions identified in the Commission's July 11, 2017 Order. This withdrawal moots Staff's objection.
- With its partial withdrawal, AT&T Kansas respectfully renews its request for
 Commission approval of its motion to stay the proceeding while AT&T Kansas reviews relevant

census block data as set forth and described in AT&T Kansas' motion. The Staff does not oppose granting that portion of AT&T Kansas' motion.

WHEREFORE, AT&T Kansas respectfully requests an Order of the Commission granting the remainder of AT&T Kansas' motion in the above captioned proceeding.
