EXECUTIVE SUMMARY:

On July 18, 2017, Atmos Energy (Atmos) filed its report detailing the calculation of its Weather Normalization Adjustment (WNA) Factor for 2017-2018. Atmos' WNA program was approved by the Commission in Docket No. 03-ATMG-539-RTS. Pursuant to Atmos' WNA Tariff Rider, Atmos must file a report with the Commission by July 15 of each year showing the calculation of the WNA Factor of the WNA calculation period. Staff has reviewed Atmos' WNA Factor calculations and finds them to be accurate at this time. The new WNA factor will begin the first billing cycle in August. No Commission action is required at this time.

BACKGROUND:

On July 18, 2017, Atmos filed a report for review and approval of its proposed WNA Factor of \$0.03271 per Ccf.¹ To calculate the WNA Factor, Atmos utilizes monthly Heating Degree Days (HDDs) derived using temperature data obtained from the National Oceanic & Atmospheric

Administration (NOAA) for twelve weather stations² located in Atmos' service territory.³ Atmos also uses heat sensitivity factors (HSF) and volumetric rates approved in Atmos' most recent rate case, Docket No. 14-ATMG-320-RTS (14-320 Docket). The calculation period is October through May and the collection period is the subsequent twelve month period August through July.

ANALYSIS:

Atmos' 2017-2018 calculations resulted in a revenue deficiency of \$3,642,918⁴. Subtracting \$36,244⁵ from the revenue deficiency for reconciliation to actual billing, provides the net revenue deficiency of \$3,606,673⁶. Dividing \$3,606,673 by current year usage, 110,254,279⁷ Ccf, determines Atmos' new WNA Factor, which is a surcharge of \$0.03271⁸ per Ccf.

RECOMMENDATION:

After reviewing Atmos' WNA Factor filing, Staff finds that the calculations are accurate and the new WNA Factor surcharge of \$0.03271 per Ccf is appropriate to begin billing. No Commission action is required at this time.
