## PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). The Commission has designated Samuel Feather, Deputy General Counsel, to act as Prehearing Officer in this proceeding. Having reviewed the files and records, and being duly advised, the Prehearing Officer makes the following findings:

- 1. On June 19, 2017, Commission Staff (Staff) issued a Notice of Denial of License Renewal Application to Black-Travis, Inc. (Operator), stating that Operator appeared to be associated with entities not in compliance with Commission statutes, regulations, and orders.<sup>2</sup>
  - 2. On July 5, 2017, Operator timely filed its request for a hearing in this matter.<sup>3</sup>
- 3. On November 13, 2017, a Status Conference was held and the parties subsequently agreed to continue the Status Conference until **Monday, December 11, 2017 at 2:00 p.m.**, by telephone.

provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or

participate in the Status Conference, hearing, or other stage of this proceeding may be held in

default under the KAPA.<sup>4</sup>

C. The parties have 15 days, plus three days if mailed, from the date of service of

this Order to petition for reconsideration.<sup>5</sup>

D. The Commission retains the jurisdiction over the subject matter and the parties for

the purpose of entering such further orders as it deems necessary.
