PREHEARING OFFICER ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On November 20, 2018, the Commission issued a *Penalty Order* against Jordan Oil Management, Inc. (Operator) for two violations of K.A.R. 82-3-111 because the subject wells have been inactive in excess of the time allowed by regulation without being plugged, returned to service, or approved for TA status.¹
2. On December 18, 2018, the Operator, through its President Jason A. Bruns, filed a letter requesting a hearing.²
3. On January 28, 2019, Commission Staff filed a Motion for Default Order, based upon the Operator's non-attendance at a January 24, 2019, prehearing conference.
4. On January 30, 2019, the Operator, through its Vice-President Anna M. Bruns, filed a letter stating "This letter is to request a withdrawal for a hearing."³

5. Based on the Operator's withdrawal letter, the Prehearing Officer finds further proceedings are unnecessary. Thus, no hearing should be held, Staff's Motion for Default should be dismissed as moot, and the docket should be closed. Staff may handle any remaining administrative matters using its standard procedures.

THEREFORE, THE PREHEARING OFFICER ORDERS:

A. This docket is closed. If any issue arises necessitating the reopening of this docket, then any party may request such at any time.

B. The Commission retains jurisdiction over the subject matter and the parties and may enter additional orders as it deems appropriate.
