**ORDER DENYING HOWELL TRUST'S MOTION TO STAY PROCEEDINGS**

Triple T Oil has filed applications for injection authority at five wells on the Weaver Lease. The Nellie J. Howell Irrevocable Trust has filed a protest. A prehearing conference was held on December 30, 2014, and the matter has been set for a February 19, 2015, hearing.


On January 8, 2015, the Howell Trust filed a motion to stay all proceedings because according to the Wall Street Journal, the federal government is planning to release new rules regarding hydraulic fracturing in the coming months. On January 13, 2015, Triple T Oil filed a response in opposition to the motion. As Triple T Oil points out, the present docket does not involve hydraulic fracturing, and even if it did, it would be improper to stay these proceedings based upon a newspaper article speculating about a plan to release regulations.

The Howell Trust's motion to stay proceedings is denied.


