You and each of you are hereby notified that WYNN-CROSBY OPERATING. LTD. ("Wynn-Crosby") has filed an Application with the State Corporation Commission of the State of Kansas (the "Commission") for the assignment of a special allowable, pursuant to K.A.R. § 82-3-133a(f), to the Mayberry B-1 well for the production of gas from the Morrow formation.
