**ORDER ADOPTING AUDIT REPORT AND CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On August 2, 2016, the Commission directed GVNW Consulting, Inc. (GVNW) to perform an audit of Rainbow Telecommunications Association, Inc. (Rainbow)<sup>1</sup> for Kansas Universal Service Fund (KUSF) purposes.

2. On March 31, 2017, GVNW filed its Audit Report of even date indicating its finding that Rainbow is current with its KUSF obligations and has no KUSF audit deficiencies related to the current audit period. Consequently, GVNW recommends the Commission close this docket.

3. The Commission has reviewed GVNW's March 31, 2017 Audit Report and concludes that it should adopt the same and close this docket.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. The Commission accepts and adopts GVNW Consulting, Inc.'s Audit Report filed March 31, 2017. This docket is hereby closed.


