## MOTION TO AMEND APPLICATION

ONEOK NGL Pipeline, L.L.C. ("ONEOK NGL") moves the State Corporation Commission of the State of Kansas ("Commission") for an order permitting it to amend its application to change the effective date of the cancellation of the proportional tariff. In support of its motion, ONEOK NGL states:

- 1. On November 1, 2016, ONEOK NGL filed an application with the Commission requesting authority to cancel in its entirety K.C.C. Tariff No. 10.0. On September 20, 2016, the Commission in Docket No. 17-ONEP-065-TAR approved a new proportional tariff, to establish new transportation movement and rates originating in four Kansas counties (Grant, Kingman, Reno and Seward) and destined for Hutchinson, Kansas on pipeline capacity leased by ONEOK NGL. ONEOK NGL has cancelled the capacity lease agreement under which the proportional transportation movements were made and will no longer be able to make these movements effective November 1, 2016.
- 2. ONEOK NGL requests leave to amend its application to change the effective date of the cancellation to February 1, 2017, to allow shipper(s) to continue to make movements under the tariff until the operator at the Hutchinson Fractionator has repaired a leak at its facility, which should be on or before February 1, 2017. ONEOK NGL has been able to extend the capacity lease agreement to provide such service until the leak repair can be completed.

WHEREFORE, ONEOK NGL requests that its application be amended so the effective date

of the cancellation of the proportional tariff is February 1, 2017.
