STAFF'S MOTION TO DISMISS REQUEST FOR HEARING AND CLOSE DOCKET

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) presents the above-captioned matter to the Commission for dismissal of Casework Solutions, LLC (Respondent) Request for a Hearing. In support of its Motion, Staff states as follows:

1. On June 24, 2019, the Federal Motor Carrier Safety Administration (FMCSA) forwarded a notice of violation(s) of the federal motor carrier safety regulations to Respondent, wherein Respondent was given 10 days to comply with the regulations.

2. As of July 5, 2019, FMCSA records indicate Respondent had not complied with new entrant requirements. As a result the FMCSA issued Respondent an Order to Revoke "New Entrant" Registration and Cease All Interstate Transportation (Federal Out-of-Service Order).

3. On July 11, 2019, the Commission issued an Emergency Suspension of Operating Authority Order (State Out-of-Service Order) against Respondent until such time as Respondent takes the necessary steps to resolve the safety matters identified by the FMCSA.

4. On July 19, 2019, Respondent filed a Request for Hearing with the Commission.

5. On or before July 26, 2019, Counsel for Staff contacted Respondent and discussed the State Out-of-Service Order and advised Respondent that Staff would reinstate Respondent as

soon as it had resolved its federal status as detailed in the Federal Out-of-Service Order. Respondent agreed to contact the FMCSA to begin that process instead of pursuing a hearing with the Commission.

6. Staff has not been contacted by Respondent since that discussion.

As of November 25, 2019, Respondent remains under the Federal Out-of-Service
Order.

8. Staff notes that the State Out-of-Service Order will remain in effect until they receive notice that the Federal Out-of-Service Order has been rescinded. Upon notice that the Federal Out-of-Service Order has been rescinded, Staff will recommend Respondent's motor carrier operations be reinstated.

WHEREFORE, for the reasons set forth above, Staff respectfully requests the Commission find that Respondent's Request for Hearing be dismissed and that this docket be closed.
