

4. Suspension of the application's effective date is required to allow sufficient time for a full investigation of this matter.

THEREFORE, THE COMMISSION ORDERS:

A. Pursuant to K.S.A. 66-117(c), the application in the above-captioned docket, and the effective date therein, shall be suspended 240 days, until Wednesday, February 25, 2026, subject to further action by the Commission.

B. Electronic service shall be utilized for serving pleading/motions and orders.

C. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).²
