



of the changes has taken longer than anticipated. At this point, Sprint Spectrum believes that the Kansas changes will be implemented within the next thirty days.

3. Concurrent with the new billing changes, Sprint Spectrum has determined that it must have those changes implemented to calculate, prepare, and distribute the refunds to customers called for in the Order. The additional time necessary to prepare those refunds also leads to Sprint Spectrum's request for additional time to comply with the Commission's Order. However, the preparation and mailing of the refund checks will lag behind implementation of the new billing system. At this point, Sprint believes that although many of the customers will receive refund checks in the next month, it is difficult to envision that all of the checks will be sent before the end of 2021.

4. Sprint Spectrum will provide periodic reports to Staff concerning progress on the refund payments, and will provide Staff with additional reports on request.

5. Sprint Spectrum has prepared and filed the updated KUSF reports and thus has complied with that portion of the Commission's Order. That compliance will be reflected in the affidavit of compliance to be filed herein.

Wherefore, for good cause shown, Sprint Spectrum moves for an additional thirty days from the date hereof to file its affidavit of compliance concerning the billing system changes and the updated KUSF reports, and ninety days to complete the delivery of refund checks.
