## PREHEARING OFFICER ORDER REGARDING ELECTRONIC SERVICE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On November 5, 2019, the Commission issued a *Penalty Order* against Lawco Holdings, LLC (Operator) for one violation of K.A.R. 82-3-400 because Operator conducted unauthorized injection at the Radcliff #7-5 well.<sup>1</sup>

2. On December 2, 2019, Operator requested a hearing.<sup>2</sup>

3. At a January 15, 2020, prehearing conference, all parties consented to the electronic service of all documents<sup>3</sup> and orders.<sup>4</sup> Therefore, the Prehearing Officer directs that service of all documents and orders may be made by email. To the extent practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is complete upon transmission.<sup>5</sup> Parties are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues.
