PETITION FOR ORDER NUNC PRO TUNC

COMES NOW Wildflower Telecommunications, LLC ("Wildflower") and petitions the Kansas Corporation Commission ("Commission") for an Order Nunc Pro Tunc correcting the territory description in the Commission's *Order and Certificate* issued herein and dated May 1, 2006 ("Order").

1. On March 7, 2006, Wildflower filed an application seeking authority to provide local exchange and exchange access telecommunications services in the State of Kansas. On May 1, 2006, the Commission issued its Order granting Wildflower's application. In ¶5 of the Order, the Commission noted that Wildflower would be limited to serving in the AT&T *and Embarq Communications exchanges*. In ¶18, the Commission stated that resale and/or interconnection agreements between Wildflower and AT&T *and Embarq* must be filed with and approved by the Commission.¹

2. Although it is clear the Embarq territory was to be included in the certification granted to Wildflower, in the Commission's findings in ¶16 of the Order, the Commission granted certification only throughout the AT&T territories. It is apparent that ¶16 contains an inadvertent error.


¹ Later, in Docket 07-WLDT-1395-ETC, the Commission designated Wildflower as an ETC in certain *Embarq* territories.

3. Wildflower states to the Commission that the territory description in ¶16 in said Order should be corrected Nunc Pro Tunc to add the italicized words set forth below so that the paragraph reads as follows:

The Commission finds that Wildflower should be issued a certificate of convenience and authority in accordance with the provisions of K.S.A. 66-131 to transact the business of a telephone public utility to provide local exchange and exchange access services throughout AT&T *and Embarras Communications* territories. Wildflower may be subject to the requirements of Section 251(f) of the Telecommunications Act of 1996 should it desire to provide local exchange service in a rural area.

WHEREFORE, Wildflower prays that the Commission's Order and Certificate entered herein and dated May 1, 2006, be corrected Nunc Pro Tunc as set forth above.
