The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On July 30, 2015, the Commission directed GVNW Consulting, Inc. (GVNW) to perform an audit of United Telephone of Kansas d/b/a CenturyLink (Toll/IXC), referred to herein as "CenturyLink", for Kansas Universal Service Fund (KUSF) purposes.
- 2. On May 13, 2016, GVNW filed its Audit Report of even date, indicating its finding that CenturyLink is current with its KUSF obligations and has no KUSF audit deficiencies related to the current audit period. Consequently, GVNW recommends the Commission close this docket.
