ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On October 21, 2016, Commission Staff (Staff) filed a Motion for an Order to Show Cause, the Designation of a Prehearing Officer, and the Scheduling of a Prehearing Conference. Staff requested that the Operator bring at least one unplugged and abandoned well held on an expired license into compliance with Commission regulations or face further sanction.¹
- 2. On January 24, 2017, the Commission issued the Order to Show Cause, Designating a Prehearing Officer, and Setting a Prehearing Conference.
- 3. On January 30, 2017, Staff filed a Motion to Cancel Prehearing Conference and Close Docket. Staff stated the Operator's license was held by John Black, who did business as

"Black & White Oper." and that Mr. Black is deceased.² Staff therefore concludes that the matter can be addressed administratively and further proceedings are not warranted.³

4. The Commission affirms Staff's view that proceeding against a deceased respondent is unnecessary. The Commission directs Staff to take such action as is necessary to resolve the matter administratively.

THEREFORE, THE COMMISSION ORDERS:

- A. This Docket shall be closed.
- B. Parties have 15 days, plus three days if mailed service, from the date this Order was served in which to petition the Commission for reconsideration.⁴
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
