1 Q. What is your name and business address?  
2 A. Cynthia Maine, 266 North Main Suite 220, Wichita, Kansas 67202.  
3 Q. By whom are you employed and in what capacity?  
4 A. I'm employed by the Conservation Division of the Kansas Corporation Commission as  
5 an administrative assistant.  
6 Q. How long have you been employed by the KCC?  
7 A. Since February 2013.  
8 Q. Have you previously testified before this Commission?  
9 A. No.  
10 Q. Do your duties include reviewing licenses that expire to determine if wells remain on the  
11 license?  
12 A. Yes. Each month I run a query to determine whether any licenses have expired with wells  
13 remaining on the license. I subsequently share my findings with litigation counsel if  
14 further review is necessary.  
15 Q. Are you familiar with this docket, 17-CONS-3127-CSHO?  
16 A. Yes.  
17 Q. What records or documents did you review in preparation for your testimony today?  
18 A. I have reviewed the license record for Operator license #3954, which includes Operator's  
19 well inventory.  
20 Q. What date was license #3954 originally issued and when did it expire?  
21 A. The license was originally issued November 30, 1988 and expired on November 30,  
22 2012.  
23 Q. Do Commission records indicate that any wells remain on KCC License #3954?  
24 A. Yes. Eight wells remain on Operator's expired license. I have attached a copy of  
25 Operator's well inventory to my testimony (Exhibit A).  
26 Q Does this conclude your testimony as of this date, August 28, 2017?  
27 A. Yes.
