**ORDER DESIGNATING PRESIDING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission finds the following:

1.        On November 6, 2023, the Rural Local Exchange Carriers (RLECs)<sup>1</sup> filed a Petition requesting the Commission open a general investigation docket for the purpose of eliminating any existing Commission requirement to distribute annually a printed directory.<sup>2</sup>

2.        On December 5, 2023, the Commission issued an Order Approving the Request for a General Investigation.

3.        On March 12, 2024, the RLECs filed a Proposed Replacement for 1967 Directive Regarding Directories. The RLECs request the Commission eliminate any requirement currently existing that mandates RLECs physically print and distribute a telephone directory to

subscribers, and allow the RLECs to provide directories in any format or manner an individual RLEC deems most cost-effective - providing a paper copy to subscribers upon request.<sup>3</sup>

4. The Commission may designate a presiding officer to conduct prehearing conferences to address any matters appropriately considered in a prehearing conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). Accordingly, the Commission designates Kyler C. Wineinger, Assistant General Counsel, Kansas Corporation Commission, 1500 SW Arrowhead Road, Topeka, Kansas 66604-4027, telephone number (785) 271-3109, k.wineinger@kcc.ks.gov., as Presiding Officer in this proceeding.<sup>4</sup> The Commission may designate other staff members to serve in this capacity.

**THEREFORE, THE COMMISSION ORDERS:**

A. Kyler C. Wineinger is designated as the Presiding Officer in this docket.
