- 1. On February 13, 2020, the Commission issued a *Penalty Order* against Prairie Gas Operating, LLC (Operator) for three violations of K.A.R. 82-3-111 because three wells had been inactive in excess of the time allowed by regulation without being plugged, returned to service, or approved for temporary abandonment status. On March 13, 2020, Operator requested a hearing.
  - 2. On August 27, 2020, Operator withdrew its request for hearing.
- 3.
