PRESIDING OFFICER ORDER REGARDING ELECTRONIC SERVICE

At a June 10, 2021, prehearing conference, all parties consented to the electronic service of all documents¹ and orders.² Accordingly, the Presiding Officer rules as follows:

1. Service of all documents and orders may be made by email. To the extent practicable, any electronically served document or order shall be attached to the email and served in pdf format.
